WILL YOU GIVE A BRIGHT GIRL THE OPPORTUNITY TO SHINE?

Every gift, no matter what size, makes a difference. Please consider adding a donation, or rounding up your monthly fee payment to support the Bursary Fund:

- 53 families giving £10 per month (over 10 months), with Gift Aid, would support another family in giving their child an outstanding education by funding the equivalent of a 50% bursary for a full year.
